2. ANALYSIS

Justin, in conjunction with National Energy Network, will complete the analysis and solicit offers from qualified third party electric suppliers.

3. PRESENTATION

4. RATE CHANGE

The annual dollar savings is calculated based on your prior year usage, and actual dollar savings will vary based on total usage in the current year.

5. POST IMPLEMENTATION

Clients will also receive periodic savings analysis (on their preference of frequency) from Donnelly Energy and National Energy Network.
